#### **IMPLICIT BIAS DEFINED**

Implicit bias is an aspect of implicit social cognition: the phenomenon that <u>perceptions</u>, <u>attitudes</u>, <u>and stereotypes</u> can operate prior to conscious intention or endorsement.

Implicit bias is thought to be **shaped by experience** and based on **learned associations** between particular qualities and social categories.

Individuals' perceptions and behaviors can be influenced by the implicit biases they hold, even if they are <u>unaware</u> they hold such biases.

	IMPLICIT BIAS	EXPLICIT BIAS
DEFINITION	Unconscious attitudes or stereotypes that affect our understanding, actions, and decisions.	Conscious beliefs and attitudes about a persor or group.
HOW IT MANIFESTS	Can influence decisions and behavior subconsciously.	Usually apparent in a person's language and behavior.
EXAMPLE	A hiring manager unknowingly favors candidates who went to the same university as them.	A person making a conscious decision not to hire someone based on their ethnicity.
ROLE IN DISCRIMINATION	Can lead to unintentional discrimination and bias in many areas like hiring, law enforcement, healthcare, etc.	A person making a conscious decision not to hire someone based on ethnicity.
MEASUREMENT	Measured using implicit association tests and other indirect methods.	Can be assessed directly through surveys, interviews, etc.
PREVALENCE IN SOCIETY	Very common, as everyone holds unconscious biases to some degree.	Less common, as societal norms have shifted to view explicit bias as unacceptable.
HOW TO AVOID	Improve self-awareness, undergo bias training, diversify your experiences and interactions.	Education, awareness, promoting inclusivity and diversity.



- Girls/boys/women who have drug addictions often prostitute themselves for money- its an addiction...hos can you blame the MAN who is "HELPING HER"
- Status/reputation of the victims
- · Family members of victims
- Beliefs and Behaviors of his supporters
- Prior Bad Acts Motion-were all prior dozen reported convictions/arrests "really" similar?

#### **VICTIMIZATION AT BEST**

- New victim- attended the Sentencing Hearing and sat in gallery NEAR victims
- C.F. never believed the victims, even sitting and listening to their stories UNTIL the sentencing hearing & REALIZED THAT IS EXACTLY WHAT IS HAPPENING TO ME...
- · Fear of victims even when offender is behind bars
- New Arrest, New Trial...more theatrics...
- Prior Bad Act Victim- the one that got away FINALLY brave enough to testify this time

#### CONCLUSION?

- Bench trial before Judge Samuel Murray; 2 victims from the first trial testified and the surprise Hawaii past victim on board this trial too
- Mull was 33-year-old when found guilty of promoting prostitution  $% \left( 1\right) =\left( 1\right) \left( 1\right)$
- $\bullet$  Sentenced to 19 months to 7 years consecutive to his prior sentence of up to LIFE

"I have been prosecuting this defendant for four years," Deputy District Attorney Laura Majewski said in a news release. "I applaud the victims for their courage to report, their courage to fight, and their strength to survive. Today is a win for survivors everywhere."



#### 1 YEAR TIMELINE OF VICTIMS FILING LAWSUITS

December 6, 2023: An anonymous woman using the name "Jane Doe" these a federal lawwiit against Diddy and two other defendants in the Southern District of New York accusing Combs of sex trafficking and gang rape, among other allegations. She was 17 at the time of the alleged assault in 2003.

 The suit claims Combs involved the high school student in a sex trafficking scheme that involved "plying her with drugs and alcohol and transporting her private jet to New York City where she was gang raped by the three individual

February 26, 2024; Rodney "Lil Rod" Jones, a former videographer and music producer for Comba; allegations of racktereding, sexual assault, sex straffsking and "grooming." Jones claims Comba forced him to procure and interact with sex workers, threatened him and served alcobic beverages laced with drugs to house party guess. He claims to have video and andio recording of the musician and his staff "engaging in serious illegal activit", "according to a complaint field in New Velt Coloral court

April 4, 2024: Combs is named as a defendant in <u>alwayord</u> brought against his son, Christian Combs, in Los Angeles. In the complaint, former yaght crew member Grace O'Marcaigh access: Christian Combs of seculally assaulting her in December 2022, when she was working on a beat chartered by the Combs family. Diddy is not accessed of sexual assaults in the lawayor but is included an inlegations of liability and adding and advertised. May 21, 2024: Crystal McKinney, a former model and MTV competition show winner, files a federal lawsuit accusing Diddy of drugging and sexually assaulting her following a Men's Fashion Week event in New York City. She was 22 at the

May 23, 2024: April Lamptoo, who met Diddy in 1994 when she was a student at New York Frahion Institute of Technology, files a Juvesuit in New York Supreme Court accounts Diddy of sexual seasuit, battery, assuit, argigent stiffction of emotional distress and violation of the victims of gender-undervated violence protection law. Lampton accurace Combo of four instances of sexual assault from the mid-1990s to the early-2000s.

July 3, 2024: Adria English, a former adult film actress, accuses Combs of sex trafficking and sexual assault in a <u>factoral lussuit</u> filed in <u>New York</u>. The usit adleges Combs and other defendants used English as "a sexual pawn for the pleasure and financial benefit of others" during parties at several of the producer's homes. The complaint also alleges Combs forced English to "engage in prostitution and sex word "Netween 2006 and 2009.

September 11, 2024: Singer Dawn Richard, a former member of the musical group Danity Kane, (<u>files a onit</u> secusing Combs of sexual battery, sexual harasofflera and false imprisonment, among other allegations. She also claims to have seen Combs "brutally beat" Ventura while the pair were dating in the 2000s.

#### 50 CENT: "P.I.M.P."

- "P.I.M.P." is a song recorded by American rapper 50 Cent for his debut studio album Get Rich or Die Tryin' (2003). It features production from Mr. Porter of D12 and was mixed by Dr. Dre. The song was released as the third single from Get Rich or Die Tryin' alongside its remix, featuring American rappers Snoop Dogg, Iloyd Banks and Young Buck, on June 24, 2003, by Interscope Records, Shady Records and Aftermath Entertainment.
- Upon its release, "P.I.M.P." was a significant commercial success, especially in the United States, where it peaked at number three on the Billboard Hot 100, while reaching the top ten of numerous national charts worldwide. The song was later certified gold by the Recording Industry Association of America (RIAA).
